1. Mr.Bad'ura welcomed delegates and guest from members Federation. After introduction and approval of GA Agenda, Mr.Bad'ura start to lead GA program.

2 . Election of Mandatory & Resolution Committee: Mr. Badura proposed Committee members: Chairman- Mr.V.Manea, members-Mr.V.Colesnic & Mr.J.Cseri. After his proposal asked members of Assembly for supplementary proposal. Members of Assembly had not supplementary proposal. Mr. Badura asked to vote for proposed Committe members – delagates unanimously voted Committe members. Commission counted on the participation and established the quorum for recognition and resolution.

3. Activity reports.

- Mr. Bad'ura expressed his satisfaction with organizations and level of competition on 5<sup>th</sup> ESHRKF Championships. During the period between GA our activity focused on improvement of Championships sporting level.

Filed information on the WKF EC decision on participation in competitions not organized in the WKF Competition rules, whether at the level of national or style federations, and possible sanctioning of WKF members to take part in such competitions. This information was introduced at the beginning of the year 2018 to ESHRKF Council and has decided that the ESHRKF Championships in Italy will be held according to WKF Competition rules.

During 2018, some WKF contestants who participated in competitions that were not organized by the WKF Competition rules and threatened with possible sanctions by the WKF turned to the IOC and the EU institutions with their submissions. Those authorities sent an opinion to the WKF EC stating that it was in breach of the EU and IOC Charter to penalize its members for participation in competitions which are not organized according WKF Competition rules. On the basis of the above information, WKF can not punish its members for participation in such competitions. The WKF at its congress will have to change the statutes of articles that allow such sanctions.

4. Approval of the Competition system and Competition rules.

Mr. Badura proposed to GA delegates to adopt a resolution that future ESHRKF Championships will have competition categories as was approved in 2017 and use Competition rules created by ESHRKF. GA members accepted this proposal.

5. Discussion

- Mr. Badura regretted that, due to the invincible policy of the world's largest karate federation, our members must submit and make decisions that complicate our competitions. He hoped that this policy would cease and we will be able to do our best to our Federation.

6. Approval of the host country of 7th ESHRKF Championships, June 2018, as the host country will be Romania.

7. Resolution

Delegates approve all issue according points of this minutes.

8. Conclusion
