1. Fee for memberships application Federation & Group – Not pay annual fee	150€

A. **Deadline for memberships fee payment is a day of confirmation of participation at the ESHRKF Championships, this is 30th March.** Surcharge of 50€ will be applied, if the payment is made within the year after end of 30th March. If the payment is made the year after, a surcharge of 100€ will be applied.

B. In case that members Federation not pay annual memberships fee and apply for his individual competitors entry at the forthcoming Championships, these competitors will be considered as non-members.

1 Executive Committee

1.1. As a general rule, the Council Members (C.M.) will not be reimbursed for travel expenses.

1.2. Hotel & Food expenses, these expenses will be covered for all C.M. whether through the host country financial obligation, whether directly through ESHRKF, no lump sum will be given. All C.M. for following the proper arrangements to be take, should confirm the attendance in writing at last two month in advance to the host country with copy to the General Secretary, about their arrival & departure. Otherwise no guarantee will be given about hotel reservation. The accommodation shall be in Headquarters hotel in individual room basis.

2. Organizing Commission (O.C.)

Half board accommodation expenses in Headquarters hotel for the Chair of O.C. will be paid by ESHRKF.

3. Referee Commission

ESHRKF will pay half board accommodation for Chair of Referee Commission and its two members.

4. Sport Commission

ESHRKF will pay half board accommodation for Chair of Sport Commission.

5. Championships financial issue

ESHRKF will financially support to the Host Country in organizing an ESHRKF Championship with sum of 60% from competitors and teams Entry fees.

6. Surety for organization of ESHRKF Championships

The host MF will pay surety fee in amount of 500€ 2 (two) month after the adjudication of the event by the General Assembly.
