- 1. Mr.Bad'ura welcomed delegates and guest from members and provisional Federation & Guests. After introduction and approval of GA Agenda, Mr.Bad'ura start to lead GA program.
- 2. Election of Mandatory & Resolution, Election Committee: Mr. Badura proposed Mandatory-Resolution Committee members: Chairman Mr.V.Manea, members Mr.V.Colesnic & P.Antonacci. Election Committee, Chaiman Mr.J.Cseri, Mr.V.Munteanu, B.Zubričaňák. After his proposal asked members of Assembly for supplementary proposal. Members of Assembly had not supplementary proposal. Mr. Badura asked to vote for proposed Committe members delagates unanimously voted both Committe members. Commission made a counter on the participation and proclaimed that general assembly established the quorum for recognition and resolution.

- Mr. Bad'ura expressed his satisfaction with organizations and level of competition on 7th ESHRKF Championships in Arad, Romania.

In 2020, due to the Covid 19 pandemic, we had no activities at all other than regular communication between members. In 2021, it was again a year marked by a pandemic and we had to cancel our sports activities. But as a substitute for the opportunity to compete on the tatami, we transferred our activity to the online space. We created competition rules for the

video kumite and kata competition, 15 countries took part in the video competition, 286 competitors and 30 judges took part in the judging. It was quite a successful replacement instead of a direct confrontation in the sports hall. We all hoped that in 2022 the pandemic would be milder and we would finally be able to hold our championships. In September 2021, in communication with the members of the council, I proposed that the 8th Championship be held in Varždin, Croatia. The members of the council agreed with the proposal and we entrusted Mr. Marjanovič to organize the Championships, Mr. Marjanovič accepted our offer and took over the organization.
